13 Planning Commissioners present: Gary Fancher (Chair), Elizabeth Gildersleeve, Jim Luckey, Mary Miller, and
14 Dick Ryon. Commissioner Heller and Commissioner von Trapp were unable to attend, and have been excused
15 from tonight's meeting. City Staff Present: Lynn Hyde, Economic Development Manager & Planner; and Mike
16 Sippo, Public Works Project Manager.

18 **AGENDA ITEM #2: Approval of January 11, 2018 Planning Commission Meeting Minutes**

19 The Minutes for the January 11, 2018 Meeting were Approved.

21 **AGENDA ITEM #3: Public Comment on Non-Agenda Items**

22 There was no comment received on any non-agenda item.

24 **AGENDA ITEM #4: Public Hearing – NBMC 19.05 Amendments – New Street Standards for**
Park Street

25 Chair Fancher explained the procedures for tonight's Public Hearing.

26 Lynn Hyde briefed the Commissioners and guests on the proposed Street Standards for Park Street, as well as
27 describing the other notices for projects that have been sent out for Park Street residents and that tonight's Public
28 Hearing is solely for street standards. Ms. Hyde, along with Mike Sippo, described the proposed changes.

30 Chair Fancher opened the Public Hearing at 7:13 PM.

32 Jessica Hatch, 315 E. Park St., Unit #29, North Bend, WA, spoke.

34 No one else spoke during the Public Hearing.

36 Chair Fancher closed the Public Hearing at 7:14 PM.

38 **AGENDA ITEM #5: Planning Commission Deliberation and Recommendation – NBMC 19.05**
Amendments – New Street Standards for Park Street

40 Mr. Sippo responded to a question posed by Ms. Hatch during the Public Hearing on speed control on Park Street,
41 and described the specific conditions on Park Street.

43 There was discussion between the Commissioners and city staff, including questions and answers, on the
44 proposed new street standards for Park Street. The discussion included speed control, sidewalks and
45 undergrounding all utilities, trucks using the road, traffic queues and possible back-ups, measuring traffic loads,
46 traffic light turn times, Washington State Department of Transportation right-of-way, traffic studies, driveway
47 approaches, site lines, crosswalk and pedestrian safety, lighting, roundabouts, the trail crossing of Park Street, a
48 cottage overlay near Park and North Bend Way, and existing conditions.

2 Chair Fancher lead the group through the proposed changes on Park Street provided in the packet for tonight's
3 meeting page by page. No further changes were suggested.
4

5 There was continued discussion of the proposed Park Street amendments, including discussion of light up
6 crosswalks, and re-striping.
7

8 Commissioner Miller made a Motion to Approve the NBMC 19.05 Amendments – New Street Standards for Park
9 Street, as presented. Commissioner Ryon seconded the Motion. The vote was 5-0. The Motion was Approved.

14 Chair Fancher reminded the Commissioners a new chair and vice chair will be voted on in March.

16 Commissioner Ryon spoke about the condition of Tanner Road.
